## Ally Pally rings the changes

### Palace breaks with tradition to consult local people


AN UNPRECEDENTED OPPORTUNITY to comment on the proposed redevelopment of Alexandra Palace has been given to us by its new Chief Executive, Duncan Wilson. The consultation, which ends soon after 6 July, heralds a new episode in the Pally saga in which Haringey Council's stranglehold has been loosened sufficiently to allow for plans that may have a chance to result in its regeneration.

#### **Impressed**

Our Ally Pally representatives, Denis Heathcote and Denise Feeney, have been busy monitoring the progress of the plans and most recently have met with Duncan specifically to discuss the impact of the proposed redevelopment on our members. They report that they have been impressed with his desire to gain the support of local people and they urge us all to take part in the consultation. Members should not be put off by previous experiences of Pally 'consultations'. As, this time, the Trust will remain in control of the redevelopment, our responses may have some impact on decisions made.

#### **Special report**

An exhibition presenting a set of plans and design concepts is currently taking place in the foyer of the ice skating rink. # Tomorrow's Ally Pally: have your say

## Some words to our members from the Pally people

'Alexandra Palace could become a major international hub for cultural and community events, learning and recreation in the future if there is support for current plans to regenerate the People's Palace,' says Duncan Wilson, OBE, Chief Executive of the Alexandra Park & Palace Charitable Trust. 'In much the same way as the South Bank has carved a cultural niche for itself in London over the last few years, we have a vision to create a vibrant cultural destination north of the river at the People's Palace.'

The Palace already stages a comprehensive programme of live music, entertainment and sporting activities, attracting visitors from around the world, but half of the building is currently in a poor state and is closed to the public.

The Alexandra Park & Palace Charitable Trust brought in world-renowned architects Terry Farrell & Partners earlier this year to create design concepts based on the vision of

Alexandra Palace's Trustees. Their vision is to regenerate Alexandra Palace and Park 'in the pioneering spirit of our founders, creating a proud, iconic destination for the local community, Londoners and visitors from around the world.'

### The Trustees would like to:

- establish the Palace firmly as a major entertainment destination;
- realise the community and learning potential of the Palace and Park;
- make the Palace more financially self-sufficient and reduce its dependence on public subsidy;
- conserve the Palace and Park sympathetically for future generations.

### The proposal's six 'big ideas'

1. Improving your first impressions and reducing the impact of the road;
2. Upgrading the entrances to the Palace;
3. Making it easier to move around inside the Palace;

4. Upgrading the Main Halls including the Great Hall;
5. A Hotel in the Palace;
6. Opening up derelict spaces such as the Theatre, BBC Studios and basement.

### Contact details

Duncan Wilson was previously responsible for the Old Royal Naval College, Greenwich and Somerset House. Under his stewardship, the Trust has appointed Donald Insall Associates, the historical buildings architectural specialists, to develop a conservation management plan for the Palace. This has now been delivered and urgent repairs are being carried out (both funded by grants from English Heritage).

### Regeneration

The most important news is the six week extensive consultation now running on the six key ideas that form the basis of the master-plan proposals for the Palace. They are improving first impressions; upgrading entrances to the Palace; easier movement inside the Palace; upgrading the main halls; a hotel in the Palace and opening up derelict spaces.

Work has started on the South Terrace to secure the structure of the colonnade. A wider package of repair work, funded by English Heritage, to the South Terrace, theatre roof and east end wings, will start in the autumn.

Tenders are being undertaken to appoint specialist advisers for the theatre and Heritage Lottery Fund, with a view to a submission later this year

for capital investment for the theatre, supporting public areas and BBC studio.

### Park Activities

The joint meeting of the Advisory and Consultative committees on 22 May received a report on the

Red Bull TMX dirt bike event of 19/20 May, which had attracted a large number of young people and their families into the Park. Red Bull had proved to be 'a superb client' despite some difficulties with an over-loud commentary broadcast. A review will be carried out to assess any damage to the grassland of the south slope.

### Cricket clubhouse

Committee members were distinctly underwhelmed by a lack of detail presented in support of an amended proposal for a water storage tank adjacent to the cricket clubhouse and were unhappy that the proposal was due to go to the Board and for planning approval at the same time. They declined to offer any advice to the Board and requested that a site visit

take place so that Statutory Advisory Committee members could judge for themselves the impact of the proposal before formulating advice for the Board to take into account.

No invitation has yet been made by the Building Schools for the Future team, which is responsible for all the plans for improving the Club grounds for the benefit of pupils of Heartlands High School.

Independent security advisers had compiled a report on procedures and management of an event held in November last year when two people attending had died. Employees, management and directors of the Trust, event organisers, Lock 'n' Load, and other contractors were exonerated from responsibility. Nevertheless the review had provided opportunities to improve services and procedures at the Palace.

### Committees

Colin Marr was elected chair of the Consultative Committee and will also chair the informal joint meetings for the next year.

Denis Heathcote was elected Chair of the Statutory Advisory Committee.

# Members clamour to join June walk

OUR CHAIRMAN, John Hajdu, has spoken of his surprise at the unprecedented numbers of members who applied to join our June walk, led by popular retired architect Bill Tyler. Places were limited to 30 but within 24 hours of John's email advising members to book their places, more than twice that number had put their names forward.

The lucky few were conducted around Fortis Green by Bill, having started off from the Clissold Arms where they had enjoyed a warm welcome from owner George Karageorgis (pictured on page 4) as well as teas, coffees and a variety of hearty snacks.

Bill interspersed his comments with a historical background. This ranged from the Ice Age geology of the area, Medieval pilgrimage routes, a hog market and an ancient brewery, to more recent local landmarks such as the birthplace of The Kinks' Ray Davies.

Fortis Green's architectural variety was covered with Bill explaining how several periods and styles had come to take their place in the area, some of them notable examples of their type. Additionally, he told us how historical developments had shaped some of the changes made to the houses we passed.

We found out about influential past and present residents, some of whom designed and constructed the buildings we looked at and such well known architects as Colin and Jennifer Jones who also left their mark on the area.

The one and a half hour walk proved so engaging and informative that many members approached Bill to ask if he would run another one next year. At the end, to cap what had been a wonderful event, the Red Arrows did a flypast in V formation on their way back from marking the Queen's Jubilee.

## Pinkham Way plant plans hit a snag

*THE PINKHAM WAY ALLIANCE is running a spirited campaign against plans for a giant industrial plant in Pinkham Way. Susie Holden of the Alliance has written in to update us on the latest news.*

The past few months have been dominated by exhaustive - and exhausting! - preparation for the public examination of the North London Waste Plan (NLWP). In addition, the Pinkham Way Alliance (PWA) has continued spreading awareness, and concentrated on an extensive fund-raising campaign.

### Questionable

The NLWP is supposed to lay the planning framework for the waste strategy of seven north London boroughs (Barnet, Camden, Enfield, Hackney, Haringey, Islington and Waltham Forest) until 2027. At a final public consultation on the plan in July 2011, the PWA (and others) highlighted some major problems:

- the manipulation of selection criteria for the site;
- highly questionable calculations of future waste flows and present treatment capacity.

Since February, a small group of local volunteers with appropriate expertise, have been expanding on these objections and preparing for the public hearings of the NLWP, which started on 12 June. They have had limited but important input from paid experts in waste, law and planning.

### Planning principles flouted

Their conclusions show that instead of being a 15-year planning strategy for north London's waste, the NLWP was primarily developed to encompass North London Waste Authority (NLWA) strategy which is to try and procure waste services for its seven member councils for a 30 year period.

Simply put, what should be a plan-led process is being driven by longer-term financial needs - directly contrary to key principles of the UK planning system.

After the five and a half years - and the spending of millions of our pounds - on the NLWP's preparation, the hearing was suspended by the inspector after only 90 minutes. In his view, the plan appears legally unsound. He is concerned that the NLWA councils failed in their duty to co-operate with neighbouring authorities outside London, which have historically accepted North London waste into landfill sites.

### Abrupt halt

The inspector has given NLWA a short period to persuade him that it has met its obligation to co-operate. If this happens, the hearings will continue in the autumn. If not, it seems that the NLWP is irretrievably damaged. More should be known shortly. From our own extensive work on it, we know that the plan is a mess, but we weren't expecting such an abrupt halt.

The NLWA is still proceeding in its aim to put a colossal plant on Pinkham Way. We are taking advice all the implications if the NLWP is found unsound. ### Village green status

In the meantime, the Freehold Community Association (FCA), whose hall is right next to Pinkham Way, in Hollickwood Park, has applied for the site to be made a Village Green. The FCA is asserting that, since local residents have - as of right - used the site as an amenity for over 20 years, that use should remain. Their case will initially be assessed by an independent adjudicator. In the meantime, Haringey Council is gathering information by sending letters to all who live within 1km of the site. We are still a few months away from a final decision.

### Fundraising Concert

The PWA is pleased to announce another fantastic chamber-music concert in St Andrew's Church, Alexandra Park Road, at 4pm, on Sunday 8 July. The Galitzin Ensemble will play, among other things, Schubert's Trout Quintet. All proceeds go to the campaign; we still require as much financial assistance as we can get. ## Planning does matter

If Muswell Hill and Fortis Green Association is still submitting representations on audacious planning applications please would you forward this email to the committee member dealing with this kind of thing?

MHFGA might not be aware that there are currently two more planning applications pending decision for 1 Treeside Place on the site of the former garden centre at the top of Cranley Gardens, both of which relate to a case which was approved by Planning Committee last November (HGY/2011/1292):

- HGY/2012/0410 is for non-material amendments
- HGY/2012/0931 is to vary the schedule of conditions

I'd like to enlist MHFGA's help if possible as it would be supportive and possibly effective to have a representation against HGY/2012/0931 from a local stakeholder group.

### Refused

The background is that over the past six years there have been loads of applications for the former garden centre site. Most recently permission was obtained from Planning Committee to have a narrower access where there had been the temporary HGV construction access.

That had been refused many times previously but was granted due to a range of applicant concessions on main issues (for example, he agreed to narrow the access by the former HGV crossover and most significantly perhaps to replace the hardstanding in front of the integral garage with soft landscaping including one proper tree).

### Claw back

The problem now is that following the granting of that permission more applications have been submitted to effectively claw back the concessions. If granted, HGY/2012/0931 would effectively negate loads of the previous decisions!

# Planning matters collapse thanks to apathy

THE PROUD ASSOCIATION TRADITION, upheld for so long, of monitoring and responding to planning applications in our area, has ceased after continued pleas for a volunteer to step forward and continue the work of our retired planning officer, Pat Bloomfield, brought little reaction.

Page 7 of the Newsletter has, for all these years, carried updates of the applications and the action taken by our Association with regard to them. The forewarning of 'a blank page' in the May issue if Pat's replacement did not make him or herself known, has now come to fruition.

## Battles fought

Chairman, John Hajdu, offers his comment on this, and joins to it a plea for more help, not just in the planning area but in recruitment, with the Muswell Hill Festival, with members' meetings and with the Colney Hatch Lane beds project:

'Your Association needs you! As those of you who came to our AGM heard (*see page 4 for more on this*) your Committee has worked very hard; we have fought many battles, as we do every year, to stand up for your rights, to help you when possible and to make sure that Muswell Hill, Fortis Green and Alexandra ward are pleasant places in which to live.

## Tailor-made

'We could do so much more if we could have some help! Surely among our 720 members, there must be somebody who is willing to give up some time and join us on the Committee. We can tailor the job to your availability and to your field of expertise; you do not need a specific skill to be able to help.

## Do you know who will be buying your health care?

*Long-standing Association member, Patrick Morreau, who is also a member of the West Haringey Patients' Panel, has written in to tell us about the recent West Haringey Residents' Meeting which dealt with Health Commissioning in Haringey.*

Association members may be interested to know about a meeting for west Haringey residents, convened by NHS Haringey, that took place on 17 April. The purpose was to bring residents up-to-date on the development of the Haringey Clinical Commissioning Group, the body that will, from next April, take over from the Primary Care Trust responsibility for purchasing health care for Haringey residents, one of the changes arising from the recent Health and Social Care Act.

### Urgent questions

The original agenda included workshop discussions in which residents could suggest ways forward for communication and engagement with the Clinical Commissioning Group (CCG). However, the pressure for information on the complex health reforms did not allow time for that; the packed room had many people wanting to ask urgent questions and it was agreed these should have priority over the workshops.

### Borough-wide

Dr Helen Pelendrides, chair of the CCG, explained that the CCG includes not only GPs but also representation from secondary care (the acute hospitals such as the Whittington), a nurse, Council representatives responsible for public health and

adult social care, and patient representatives from the east and west of the borough. This breadth of representation means that everyone involved with health care in Haringey is represented on the CCG. The CCG also works with the Haringey Health and WellBeing Board to address health issues across the borough. The CCG has been a 'shadow' group since July 2011 but expects to be fully authorised by the Department of Health and become a statutory body in April 2013.

### Value for money

Dr Pelendrides went on to say that this new commissioning arrangement offers great opportunities for 'achieving more through working together'; to, for example, improve outcomes and reduce inequalities, improve prevention and increase early intervention, and to integrate health and social care more closely.

It also offers patients a greater voice in commissioning decisions through practice and area patient panels. She expected residents to start to see decisions about their services happening locally and in partnership with the Health and WellBeing Board, and that they will also see good quality, efficient and value for money services, designed in partnership with the local community and meeting local needs.

### More meetings

Dr Pelendrides's presentation gave rise to many questions which I do not have space to report. This is clearly the start of an ongoing dialogue between the CCG and patients, and I expect another meeting will be held before too long.
